- ✓ Helped college in organizing some need-based programmes/activities in nearby villages for specific outcomes.

- ✓ Gave definite inputs on the basis of which college can adopt villages.

- ➤ Introduction of training-cum- coaching for service in defense sector.(under consideration)


Problems encountered and resource required:

Title of the Practice:

Objective of the practice:

- ❖ To ensure better Health and Sanitation for all.
- Setting and working towards goals and targets for reduction of waste, conservation of energy and resources.

The context:

"Clean College and Green College" is the axiom as far as the environment is concerned. The mission of the college is to develop its students into good citizens of India in all respect. The college is committed to sustainable development and its engagement to social and environmental issues is very evident and is lauded from various quarters of the society.

Environmental consciousness has been an integrated component of the college activities which is evident from the constitution and function of a special committee called ECAC (Environmental Conservation & Action Committee), innovative in nature and categorically earmarked for the action relating to environment. Therefore, the College welcomes everyone to a lush green campus and a plastic free environment in order to raise the environmental consciousness of the students, teachers, and guardians alike. The collective efforts made by all help to maintain a better environment for achieving the goals for academic excellence.

The Practice:

- ➤ Plantation of trees and saplings at regular intervals to provide greenery and fresh air.
- ➤ There is documentation of the trees and plants of the campus by the **Environmental Conservation and Action Committee** (**ECAC**). The committee sees to it that all environmental norms are maintained to make the college and the stakeholders conscious in this regard
- ➤ The college adopts the policy of e-governance in almost every field to minimize the use of papers and is exploring the idea of Refuse-Reduce-Recycle and Reuse to be introduced very soon in true sense.

- Awareness programmes on environment are held regularly to spread the environmental awareness among the students and staff members.
- ➤ Light fixtures are replaced with LED bulbs.
- Rain Water Harvesting and Water Conservation is there in the college campus.
- > Students are regularly advised to keep their classrooms and campus clean and to save the wastage of power and water. They are asked to stay away from any kind of tobaccos and keep the campus plastic free
- ➤ The college has adopted healthy practices in order to inculcate good habits and responsibility towards society among the students through awareness programmes.
- The ECAC has put restrictions in the use of plastics in the campus.
- ➤ There is solid-waste management in the college campus.
- ➤ Installation of solar panel.
- ➤ Use of saplings in place of flower bouquets in different events to felicitate dignitaries.

Evidence of success:

Keeping the issue of environmental protection in mind, developing a green belt within the college campus is one priority area. To materialize this idea and to use the college area for social forestry, a garden of medicinal plants has been established in the back side of the college and a flower garden in front of the college. We have stopped the conventional practice of offering flower bouquet to the dignitaries in any of our programs and provide saplings instead

Our above efforts helped us to bag the Recognition of Swachhta Action Plan Institution by Mahatma Gandhi National Council of Rural Education, Ministry of Education, Govt. of India.

Problems encountered and resource required:

Lack of space in the campus to execute different activities related to environment. The college is built only on 01 acre of land which is quite insufficient to carry out extensive green activities. Before the appointment of the present Principal the college was running by the TICs and the frequent change of the chair was putting hindrances in the strategic planning and successful deployment of it which is evident from the data available in the college. Furthermore the grim financial condition of the college always puts obstacles on its way of planning and execution. The marginal strength of the staff, both in Teaching and Non-Teaching category, is also another emerging problem. The Covid 19 pandemic situations adds salt to the injury. The spread of Covid-19 has compelled us to put on hold the schemes till the normalization of business in all spheres
